### **National Tournament Director Report:**

Mr. Nanez expressed it is tournament director/handicap person responsibility to submit your tournament scores to minimax. Deadline to submit tournament scores is the 25<sup>th</sup> of each month. Mr. Nanez will work closely with Brownsville to make sure everyone has ten (10) tournaments rounds to qualify for the National Golf Tournament.

Mr. Jesse Pena stated, "National Tournament Dir. & Treasurer will work closely with each other to have all members qualified to play and chapters are paid in full before the National Tournament in Brownsville".

Mr. Nanez requested all chapters to identify all Seniors and Super Seniors when submitting reports to minimax.

**National Tournament Director Report Continued:**

Mr. Nanez addressed to the President Mr. Pena, if there should be an agreement to identify all Seniors and Super Seniors to minimax.

Mr. Vicinaiz stated information that is being handed out remains the same. Waiting for the results after today meeting on the senior proposal, this will determine how much the cost will be.

Mrs. Rivas stated we are working diligently to welcome each one of you to Brownsville next summer. Presented budget in Dallas and was approved. - Eligible for skins in their own flights - optional

**National Seniors (50 and over) Golf Tournament Rules and Guidelines per  
National By\_laws Section 14  
Bobby Pena – Ft. Worth**

**Suggestion: Leave as is**

**QUALIFICATIONS**

1. A PAGA senior participant must be fifty (50) years or older the day of the National senior golf tournament.
2. Any senior who meets all local chapter and national requirements and has an established handicap may participate in the National senior's golf tournament.
3. A senior participant must have proof and verification of age.
4. The initials SR must appear on the minimax roster for each senior.

**COMPETITION:**

1. The type of play will be full handicap within the same golf course as determined by the Host City and played in conjunction with the National Tournament & Convention.
2. Play for the National Senior Golf Tournament will be (18 or 36) holes with full handicap.

**Omit 3,4,5**

3. The first day of play during the National Tournament & Convention will be used for the National Seniors Tournament (if only 18 holes are played).
4. Seniors age and handicap must be on entry form, unless Registration Forms has appropriate columns with specific information.
5. If possible, all Seniors will be paired for each round of golf.
6. Play will be governed by the National Tournament Director and the host city Tournament Director.

**TROPHIES & RINGS**

1. There will be three (3) places in each flight provided there are a minimum of 25 participants per flight. If there are less than 25 participants in a flight, the Host city may reduce the number of awards per flight and award a minimum of two (2) places per flight.

**Low net**

2. There will be one(1) trophy and one (1) National ring for low gross in each golf course.

**Omit 3**

3. A participant can win low gross and one of the other place trophies in each golf course.
4. All senior trophies and rings will be provided by the host city and awarded on Friday night in conjunction with the National Tournament & Convention.

**Discussed how to fund the trophy and rings**

**Have 5 flights with 5 rings \$10.00 optional if you want to play**

**ENTRY FEE**

1. The Host City will present to the delegates the proposal for the National Seniors Golf tournament for review and approval in conjunction with the submittal of the National Tournament & Convention proposal.

## **Omit 2**

2. Seniors who only prefer to play in the senior golf tournament must still pay the National Tournament & Convention entry fee.

## **Senior Tournament will play 2 days with handicap No Super Seniors flights**

### **National Tournament & Convention Expenses**

#### **Noe Guerrero – Corpus Christi, TX**

- Utilize 501 (C) Junior Golfers – status - Corp. sponsor
- National Committee – means and ways committee and National Convention Committee
- Collect pass dues from all chapters – before the Convention, tally, documented, updated and publicized. A lot of chapters that are not present, safe a lot of money that do not attend and it is an expense.
- Chapters that do not attend these meeting should be charge a little fee.
